TMclass

- Does your description clearly describe the goods or services you will use your trademark with? Are you sure in which class you should apply? Do you want to know which terms are acceptable to the Office you apply for?
- 商标对应的商品或服务是否描述清晰？是否确定应该申请哪一类商标？提交申请的商标局接受哪些条款？
- **Features:** 27 harmonized offices, 38 participation offices, harmonized database, China participating
- **特点:** 28个协调机关、38个参与机关、协调数据库；中国参与其中

Similarity Tool 相似性工具

- If you find the same or a similar trade mark do you know which G or S may present a problem? If you are faced with an opposition / invalidity what are the criteria to assess similarity of G&S?
- 如果发现了相同或相似的商标，是否知道哪种商品或服务可能会出现问题？遭遇他方的异议/无效主张时，评价商品和服务相似性的标准是什么？
- **Features:** Search facility of 2 types of goods and services, and see whether similar or not
- **特点：**可搜索两种商品和服务，比较其相似性。

Enforcement database 执法数据库

- Connects Police, Customs and IPR Holders of 28 Member States
连接28个成员国的海关警察、海关和知识产权权利人
- Provides details on IPRs and helps to detect counterfeit products
提供有关知识产权的详细信息，并帮助侦测假冒产品
- Functions both ways
