

Through advanced technology such as model algorithm, real-time risk investigation of the whole platform is carried out, and risk is found in time.





Product anti-counterfeiting

商品经过"一物一码"的标识,并且将全过程流转的信息写入区块链。区块链上信息不能随意篡改,商品从生产到运输再到最后销售,每一个环节的信息都被记录在区块链上,可以确保商品的唯一性。造假商品很难具备合乎特定规则的商品标识。

商品从生产到销售,每一个环节的主体都以自己的身份(私钥)将信息签名写入区块链,信息不可篡改,身份不可抵赖。一旦出现纠纷,能够快速定位问题环节,进行举证和追责。




供应链协同




