TRADEMARK: MADRID PROTOCOL & OMNIBUS LAW

- DGIP is Office of Origin for Indonesia as a Madrid Protocol member since January 2018
- The filing language is English only
- Applications (as September 2020):
 - as Origin Office: 130
 - as Designation Office: 16.567
- Omnibus Law → Substantive examination:
 - 30 days for application without objection from 3rd parties
 - 90 days for other



INDUSTRIAL DESIGN: LAW REVISION

- Recent Progress: On going discussion
- Issues:
 - Novelty criteria (inc. similarity)
 - Registered Design
 - Unregistered Design with recordation
 - Appeal Examination
 - International Registration on Industrial Design (plan to accede the Hague Agreement-Geneva Act 1999)

PATENT: BUDAPEST TREATY, S&E, REGULATIONS



- Plan to accede Budapest Treaty
- Enhance Facilities for Patent Searching & Examination (S&E) → EPOQUE Net
- Recent Development Patent System
 - Presidential Decree on Procedure of Government Use (Pres. Decree 77/2020)
 - Omnibus Law
 - Amendment of Patent Law 13/2016

COPYRIGHT: MARRAKESH TREATY & BEIJING TREATY

- Marrakesh Treaty for Visual Impaired Persons and Beijing Treaty for Audio-Visual Performances → already adopted in Copyright Law No. 28 Year 2014)
- Recent Progress
 - Marrakesh Treaty → on 28 January 2020, Indonesia has submitted the ratification instruments for Marrakesh Treaty
 - Beijing Treaty → on 28 January 2020, Indonesia has ratified the Beijing Treaty, to be the 30th Party, and it determines the entry into force of the Beijing Treaty



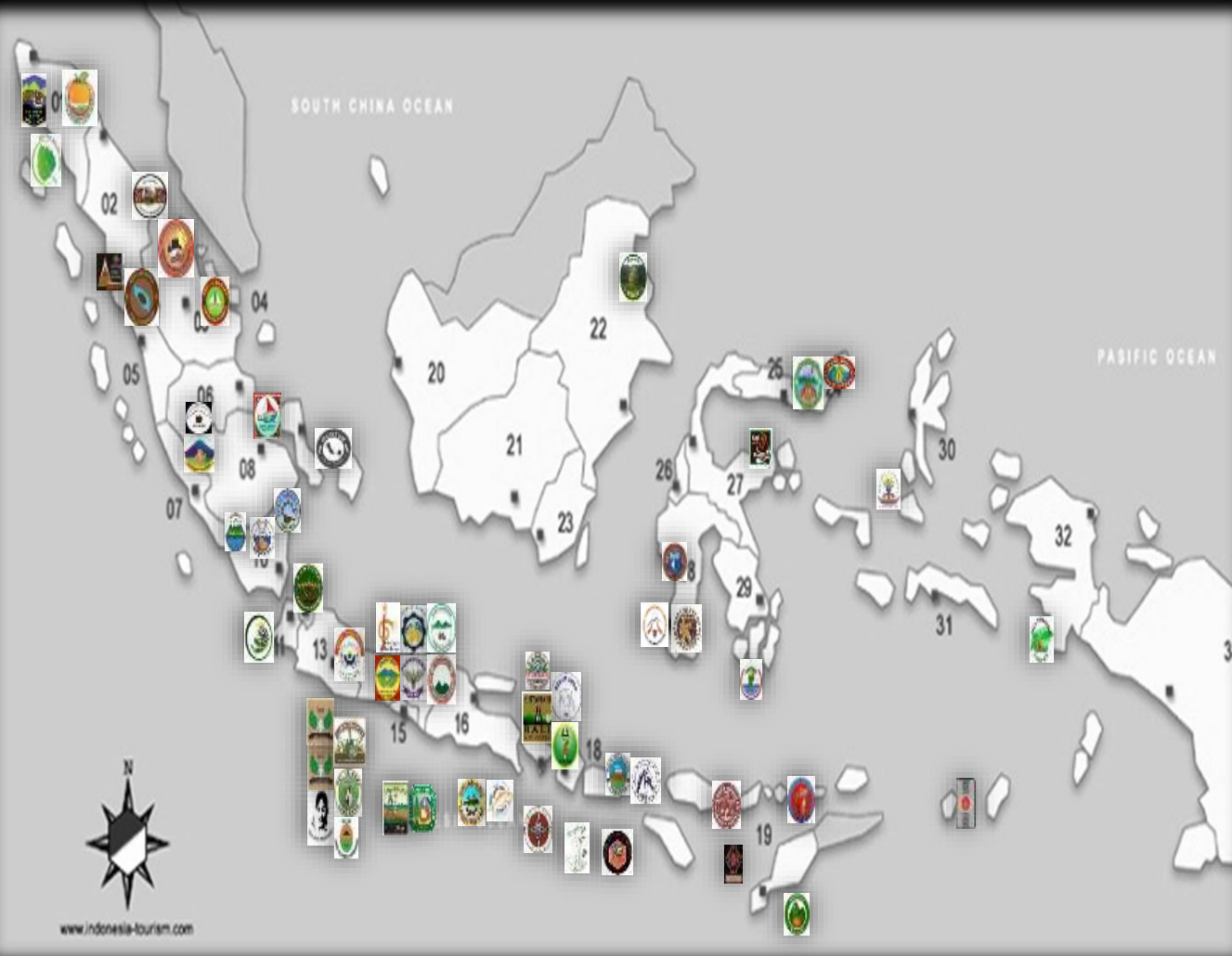

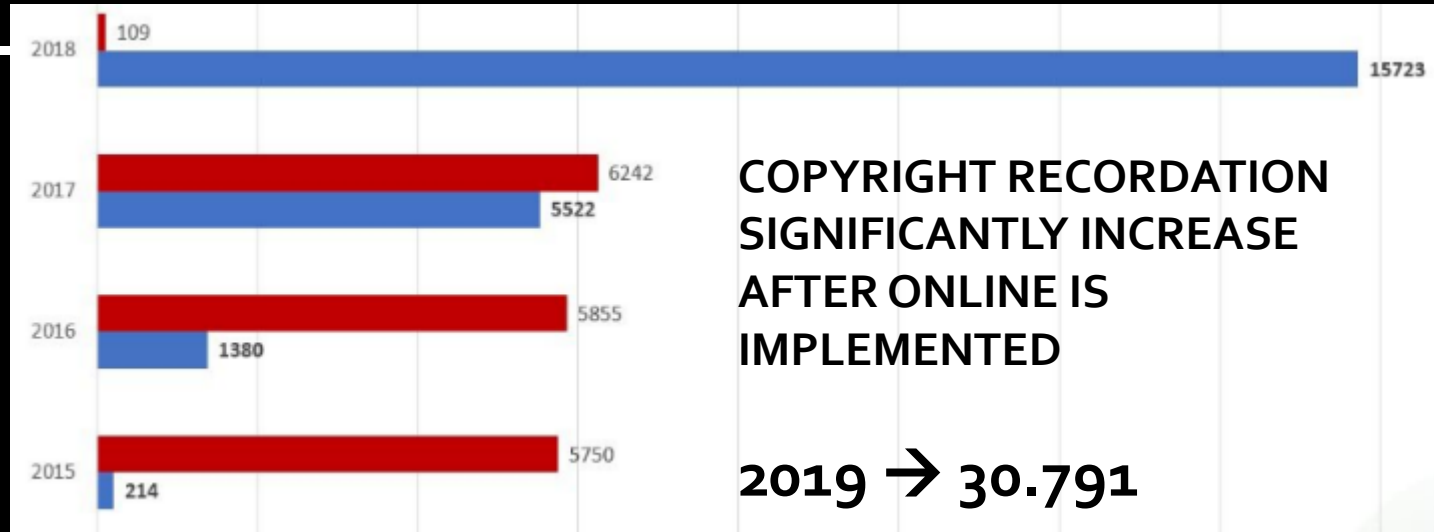
