

□ high gross margins 毛利率高

- □ Technology makes copying easier (and also the identification of varieties) 技术让复制(和品种鉴别)更为容易
- □ copying is cheap, requiring little capital investment 抄袭成本低,基本无需资金投入
- □ no distinction between legally and illegally produced harvested product 合法与非法生产的收获物无法分辨
- □ illegality does not bother consumer 使用非法获取的种子,不直接对消费者产生影响
- □ often no perceived health hazards (like pharma, pesticides or car parts) 健康危害不易察觉(类似药品、杀虫剂或汽车零部件)
- □ vegetable seeds are often <u>small volume</u>: easy to transport 蔬菜种子通常<u>体积小</u>:易于运输

<u>'HORIZONTAL'</u> ENFORCEMENT (LEGAL DISPUTES BETWEEN BREEDERS) OF BREEDERS RIGHTS, WHERE TIME AND EVIDENCE-GATHERING CONSTRAINTS ARE LESS CRITICAL, HAS PROVEN TO BE FEASIBLE AND EFFECTIVE;



- 在时间和取证方面限制不大的情况下,育种者权利的<u>"横向"</u>执法(育种者之间的法律争端)可行且有效。
- <u>'VERTICAL ENFORCEMENT'</u> OF PVR TO COMBAT PIRACY DOWNSTREAM IN THE VEGETABLE BUSINESS CHAIN PROVES TO BE MORE DIFFICULT AS IT REQUIRES A SUPPORTING LEGAL AND INSTITUTIONAL FRAMEWORK:
- **因为需要支持性法律和制度框架,为打击蔬菜产业链下游侵权而进行植物品种权"<u>纵向执法</u>"难度更大**:
 - evidence of infringement cannot be obtained by the right holder himself as inspections of the growers are difficult
 / impossible 权利人自身无法获得侵权证据,因为难以/无法对种植者进行检查
 - without active help from authorities, breeders' enforcement efforts are unsuccesful 没有主管部门的积极协助, 育种者无法实施有效执法
 - PBR enforcement is in some countries hindered by the lack of effective enforcement of the national seed marketing regulations. 在部分国家,种子销售监管执法不严,植物育种者维权困难。
- CONSEQUENTLY, SOME WELL ORGANISED PIRATES HAVE SUCCESFULLY ESTABLISHED PROFITABLE BUSINESS MODELS.
- 进而出现有组织不法侵权,形成暴利黑色产业。





1. All varieties have to be registered as precondition for marketing of seed 所有品种都必须登记,这是种子销售的前提条件



All new varieties are technically examined. 所有新品种要通过技术测试。

To be listed in the National Catalogue of Varieties, varieties must meet standards on: 要列入国家品种目录中, 品种必须满足下列标准:

- Distinctness 特异性
- Uniformity 一致性
- Stability 稳定性

All varieties which are admitted are published in an Official Journal. 所有登记品种均进行官方公告。

- TOMATO, WATER MELON, MELON, EGGPLANT 番茄、西瓜、甜瓜、茄子
- SUBSTANTIAL VEGETATIVE PROPAGATION IN TOMATO IN MEDITERRANEAN BASIN (**20** % IN SPAIN AND ITALY; IN CHERRY TOMATOES IN ITALIAN REGIONS UP TO **40**%. 地中海盆地大量实施番茄营养繁殖(西班牙和意大利占20%;圣女果营养繁殖在意大利地区占比高达40%)



2) <u>REPRODUCTION OF SEEDS OF OPEN-POLLINATED PVR CROPS (LETTUCE, BEANS) 自然授粉PVR作物的制种</u> (生菜、菜豆)




THE STEPS WE NORMALLY FOLLOW 我们通常遵循的步骤:

- 1. Intelligence reports on illegal reproduction received by AIB AIB收到有关非法繁殖的情报
 - Growers using a PVR variety are unknown to seed company 种植者擅自使用未经种业公司授权的PVR品种
 - Persistent rumors in the market 市场持续出现传言
 - Complaints from other growers on unfair competition 其他种植者提出不正当竞争投诉
 - Observations from seed company sales representatives / technicians: "this grower uses our genetics, but we have not sold to him" 种业公司销售代表/技术人员的观察: "该种植者使用的是本公司遗传材料, 但公司从未与其发生销售关系"
- 2. Verification of the intelligence by AIB AIB确认情报
- 3. If intelligence found credible, denouncement is made to authorities 情报确认后,向主管部门举报
 - Name of suspect 嫌疑人名称
 - Address and GPS coordinates of greenhouse/plot 温室/地块的地址和GPS坐标
 - Supporting evidence like pictures, labels, etc. 图片、标签等支持性证据





Initial Contact 初步联系





- The member companies should conduct a SNP test of the infringement for proof of the infringement Usually with the assistance of AIB 会员单位应当对侵权开展SNP测试, 获取侵权证据 (通常在AIB的协助下进行)
- AIB will discuss options and steps for legal action AIB讨论法律行动的选项和步骤
- AIB will not take action until we get express approval from the member company 在获得种业公司的明确同意之前, AIB不会采取行动



The AIB will review the case and the information AIB审阅案件和相关信息



- A discussion between the team members will determine the next steps and which venue should be contacted and where 团队成员讨论确定下一步计划,确定审理机构以及地点
- The AIB team will determine the best group to contact and the best location; this determination might take time AIB团队确定在下一步取得联络的最佳机构和地点(可能需要一定时间)
- Once an agency has been chosen AIB will initiate contact between the member company and the chosen agency 一旦选定审理机构,ABI会启动会员企业和所选机构之间的联络







- Part of the Investigation includes court actions by the AIB legal team 调查工作可能包含AIB 法律团队进行的法庭行动
- The AIB legal team will review the case and will work with the member company and the Italian authorities AIB法律团队审阅案件,与会员单位和意大利主管部门协作
- The AIB legal team will will be the point of contact between the courts and AIB/Member company AIB法律团队成为法庭和AIB/会员单位之间的联络点

- This press release will be decided upon and ready to go prior to the ruling of the court 法院判决之前,定稿并做好发布准备
- The press release will be issued to AIB friendly members of the press immediately after the ruling is announced. 判决宣布之后,向对AIB态度友好的媒体分发新闻稿

- The overall feeling from these discussions is that there is not a great threat of infringement in Mexico at this
 time for AIB companies and their crops 整体结论: 在墨西哥, AIB公司及其作物目前未受到较大侵权威胁
 - The majority of vegetable seed sales are to large growers or large distributors. These large organizations don't mess with their sales and actions 绝大部分蔬菜种子向大型种植商或大型分销商销售。大型机构在销售和经营过程中较为规范
 - The majority of crops grown in Mexico for AIB companies are for exportation. The exporters have high standards for their products绝大部分在墨西哥种植的AIB作物用于出口。出口商对其产品要求较高
 - There are infringements and possibly \$30 million of loss in the vegetable seed sector but there are issues with enforcing or acting on these infringements 蔬菜种子行业或存在侵权,可能造成了3000万美元的损失,但是侵权执法较为困难

AIB will continue to monitor the situation and will remain in contact with the Agricultural community in Mexico AIB会继续监测情况,与墨西哥的农业各方保持联络


