BAD FAITH

恶意注册

Broad concept:

Can cover any trade mark registration made with a "dishonest state of mind".

广义概念:

可以涵盖任何 "不诚实" 的商标注册。



NOT FOCUSED ON USE!

不重点关注商标的使用!



FOCUS ON GENUINE USE

重点关注商标的实际使用

Revocation

撤销

for non-use 5 years after registration

注册后连续五年不使用的 商标





BAD FAITH

- NOT necessarily 2 signs in + 未必是两个商标发生冲突。 conflict.

- When 2 signs:
 - Use of the earlier right is NOT a requisite.
 - Nor is use of the contested trade mark.

- 当存在两个商标时:
 - 在先商标是否使用并非必要 条件。
 - 系争商标是否使用亦非必要 条件。



BAD FAITH 恶意注册

Bad faith can arise where the primary intention is:

主要意图是如下情形的,可能存在恶意注册:

 to block a third party's <u>use</u> of an earlier right or; • 阻止第三方使用在先商标的;

 to benefit from the earlier right's attractiveness through <u>using</u> the contested trade mark on the EU market.

• 通过在欧盟市场<u>使用</u>系争商 标,攀附在先商标以<mark>牟取利</mark> 益的。

Key point: whether the applicant was aware of the use of the earlier right

- Nature of the market
- Period of <u>use</u> of identical or similar earlier right
- Chronology of events
- = relevant factors for assessing the **presumption of knowledge**

关键点:申请人是否<mark>明知在先商标</mark>的 使用

- 市场性质
- 相同或类似在先商标的使用期限
- 事件年表
- = 对知情推定进行判断的相关因素





29/09/2021, T-592/20, AGATE

The evidence provided shows only **use** of the prior Chinese trade mark 'Agate' in Bulgaria between 2014 and 2017.

提供的证据仅显示在2014年至2017年间,在保加利亚<mark>使用了在先中国商标</mark>"Agate"。

For assessment of bad faith, it is not the use of the contested trade mark that is examined, but rather whether the proprietor intended to make use of the contested trade mark.

判断是否恶意注册,并非通过 <u>审查系争商标的实际使用</u>,而 应考察权利人是否<u>具有使用系</u> 争商标的意图。

NO INTENTION TO USE OF THE CONTESTED

TRADE MARK!

本案中,权利人无意使 用系争商标!



07/09/2022, T-627/21, MONSOON

There is bad faith when it becomes apparent, that the contested trade mark was applied

注册系争商标明显

季风

without intending to use it,

无意使用

solely with a view to preventing a third party from entering the market.

目的仅为阻止第三方进入市场的,属于恶意注册。



CONCLUSION 结论

 Bad faith when the contested trade mark is used. • 不当使用系争商标,会被认定恶意。

 Bad faith as well when <u>no</u> <u>intention at all of using</u> contested trade mark if there is <u>no rationale</u>. 无意使用系争商标、没有 合理原因的 ,也会被认定 恶意。
