







EU - Origins and routes



Figure 7 highlights IPR products trafficking flows by region in 2023. The largest trafficking flows of IPR products were from Asia/Pacific to Western Europe (9,550 instances, 45.6%), from "Unknown" to North America (7,066 instances, 33.8%), and from Asia/Pacific to South America (1,001 instances, 4.8%). No other flow exceeded 1,000 instances.







 e.g. use of hidden links



Wines

- Fake labels printed by professionals
- Sold around the world
- Offences investigated:
- infringement of Geographical Indications
- swindling
- money laundering.







Results

- 6 arrests
- 14 house searches
- seizures of large quantities of wine (Grand Cru domains)





2.1 Investigations

Perfumes



- Bottles prepared in Italy
- Perfumes coming from the Balkan countries

Results

- 15 individuals reported to the judicial authority
- Dismantling of a production site
- 2 000 counterfeit items
 (perfumes, clothing, watches and IT accessories)
- Brand labels
- Around 2 000 perfumes bottles still to be assembled
- Cash


Operation FAKE STAR





THE EUIPO'S KEY ROLE AND RESPONSIBILITIES

- Protects and manages European Union (EU) trade marks, EU designs and Geographical Indications (GIs) for craft and industrial products covering the territory of the 27 EU Member States.
- Is responsible for the EU Register of Geographical Indications.
- Promotes common services and standards with National Intellectual Property (IP) Offices of the EU for the benefit of businesses and citizens.
- Manages the EU Observatory on Infringements of IP Rights.

- Assists in strengthening the enforcement of IP rights and combats counterfeiting with a network of experts, specialist stakeholders and enforcement entities.
- Manages the Orphan Works Database, Out-of-Commerce Portal and Agorateka in the area of copyright.
- Collaborates with non-EU IP offices to promote and strengthen IP systems worldwide.
- Manages international EU-funded IP projects in Africa, America, Asia and Eastern Europe with a total budget of more than € 48 million.
- Implements more than 100 extensions of EU IP common practices in third countries.

IPEP is the single e-filing and AFA management point for 24 Member States and alternative system for Germany, Spain and Italy.

All the AFA information of a rights holder is displayed and visible in IPEP, ready to be managed

To ensure quality and proper processing of data, it is advised to fill in and

manage AFAs electronically





Customs Application for Action (AFAs) – electronic filing and extension

Application for Action (AFA)

Protect your rights on the border providing the custom authorities with the necessary information about your rights, contacts and products.

The Application for Action allows the applicant to request the customs authorities to take action with respect to goods suspected of infringing an intellectual property right.

Further details can be found in the Manual for Application for Action provided by DG TAXUD.
